2045 REGION 9 LONG RANGE TRANSPORTATION PLAN

Virtual Public Input Notice on Draft Plan

(Rock Island, January 13, 2021) —Every five years, the Region 9 Long Range Transportation Plan (LRTP) is re-evaluated. The update process considers changes in our transportation system and economy, looking 20 years into the future for the area of rural Scott County and all of Muscatine County, Iowa.

Regional officials with Bi-State staff have prepared a draft plan with guidance from the Iowa Department of Transportation. It is ready for public review. The plan includes transportation goals, existing and proposed transportation system improvements, and survey input from citizens within Region 9. Comments from the survey noted future improvements and current issues, such as road conditions, traffic congestion, bike route safety, and intersection safety. The most important goal to these citizens was safety/security within the area. Public input is scheduled prior to the adoption of the plan.

A public hearing is set for Friday, January 29, 2021 at 11:00 a.m. as part of the Region 9 Transportation Policy Committee Meeting.
